Problem(s)	Halton is a borough in Runcorn and in the latest Index of Multiple Deprivation (IMD) this area was ranked 519 out of 32,844 in England.
	This project aims to tackle several problems that are faced by people living in Halton.
	Fuel Poverty



One of the biggest problems people in Halton face is fuel poverty. This tends to predominantly effect low-income households with the least energy efficient properties who pay the most for their energy.

As there is also a high incidence of unemployment in Halton this means they have less income and will therefore not have as much money to heat their homes. This leaves people in a position where they either heat their home or feed their family.

Fuel poverty leads to people living in damp, cold living conditions.

The National Institute of Care Excellence (NICE) has a list of groups it considers most at risk from living in damp, cold living conditions, these include the following:

- Individuals with respiratory conditions
- Individuals with cardiovascular problems
- · Individuals with disabilities
- Individuals over the age of 65
- Young children
- Pregnant women

ONS statistics report that there were 50,100 excess winter deaths in 2017-2018 and it is estimated that 10% were directly attributed to Fuel Poverty.

According to the Government's annual data review, in 2018, 2.4 million households were in fuel poverty. ¹

<u>Unemployment</u>

According to the latest official data, there were 5,340 unemployed Halton residents in November 2020, up by 2,487 since the same month a year before.

The figure was also up by 2,073 from five years earlier. Among 18-24-year-old young adults, the number stood at 1,064 claimants, up 85% year on year.²

People who are unemployed also find themselves in debt and struggling to pay their heating bills and then find themselves in poor health both physically and mentally.

<u>Debt</u>

³Five per cent of adults in the UK have unsecured debt equivalent to six months or more of their income, when you take into account their financial assets such as their savings, which is commonly used as an indicator of unmanageable debt. When looking at different groups in society however, the proportions of people with unmanageable debt are far higher. For example:

 Those in the lowest income group are three and a half times more likely than the highest earning fifth of the population to have

debt worth more than six months of their income (7% compared to 2%)

- 20–29-year-olds are twice as likely than 30-39 year olds to have debts worth more than six months of their income. (14% compared to 7%)
- Private renters are nearly twice as likely as those with a mortgage, and five times as likely as those who own outright, to have debts worth six months of their income. (10%, 6%, 2% respectively)

When we factor in unemployment, low income, drug and alcohol abuse and mental health the chances of people being in debt are huge.

These people often do not have access or are embarrassed about seeking advice to get them out of debt.

Lack of Awareness on the Dangers of Carbon Monoxide

One in six households across the Northwest were found to have an unsafe appliance when inspected.

Many customers who live in deprived areas have little or no awareness of the dangers of CO. Appliances are often left un-serviced due to financial constraints and CO alarms are often viewed as a luxury item. Families that are struggling to provide food for their family do not see staying CO safe as a priority.

Updated February 2024

Due to the success of the project, Halton have requested an additional advisor to cope with demand. Now the project is in its third year more people are aware of the services and are presenting with issues that require one-to-one appointments.

There are currently two advisors, but they cannot fulfil the number of appointments required.

Updated June 2024

The project's continuing success has led to wider growth and increased interest from the community. This increased interest presents the opportunity to extend the current project and enable The Halton Brook and Palace Fields Community centres to effectively manage more appointments.

Over the past 12-18 months, there has been a significant increase in the number of people asking for help as they struggle with the challenges of everyday living. The demand for benefits and energy efficiency advice is continuously growing.

Increased living costs mean many households are cutting back on essentials, with low-income households most at risk. It is not uncommon for adults to report they skip meals so they can feed their children or warm their homes, nor is it unusual for older people to feel frightened to

Scope and Objectives	Project Scope Cadent will provide Halton Brook with £149,017.29 of VCMA funding to deliver a two-year centre for warmth and a cookery project. Centre for Warmth. The two-year 2022-2024 agreement replicates the previous project model in other Centres for Warmth, whereby specialist benefits advisors are employed using the VCMA. This service provided vulnerable households with essential financial support and also created a very strong SROI.

Project Objectives

Cadent will measure the success of the Centre for Warmth Halton Brook against the achievement of the following objectives:

- To deliver income maximisation advice to 3,976 households per annum.
- To deliver energy efficiency advice to 1,508 households per annum.
- To deliver carbon monoxide safety advice to 1,000 per annum
- Provide 200 alarms per annum to households that do not have
- To alleviate stress and anxiety regarding keeping the home warm for approximately 1,200 customers per annum.
- To support 600 people to sign onto the PSR register per annum.
- To generate a positive social return on investment see the below relevant section for more details.
- To educate 112 Families on how to cook more efficiently, healthier and on a budget by hosting the Community Cooking course.

The additional funding will provide a third advice worker, offering advice on income maximisation, energy efficiency, CO and PSR. The funding will also provide free meals and activities for the community.

- To deliver income maximisation to an extra 500 people.
- To deliver energy efficiency advice to an extra 760 people.
- To deliver CO advice to an extra 760 people.
- To deliver PSR advice to an extra 760 people.
- To register an extra 76 people to the PSR.

Updated June 2024

Cadent will provide Halton Brook & Palace Fields Community Centre with an additional £229,022.81 for a 21-month extension. The funding will enable the centres to provide additional services as listed below.

- Deliver PSR advice to 1,900 individuals.
- Distribute 3,000 PSR leaflets only with no conversation.
- Register 300 individuals to the PSR.
- Provide energy efficiency advice to 1,000 individuals via in-depth one-to-one or group conversations.
- Distribute 9,600 energy efficiency leaflets only with no conversation.
- Provide 14,400 individuals with income maximisation services.
- Provide 40 slow cookers at dedicated events and as individual needs emerge.
- Provide 121 carbon monoxide awareness conversations to 1,100 individuals.
- Distribute 3,000 carbon monoxide leaflets only with no conversation.
- Distribute 1,300 carbon monoxide alarms.

Evidence of Stakeholder/Customer Support	Our enhanced engagement programme for the RIIO-2 business plan identified a variety of proposals, including Cadent's ambitions for tackling fuel poverty that were of high importance to Cadent customers and expert stakeholders.
	When we asked our stakeholders "To what extent do they support Cadent funding the following activities?" 70% of stakeholders supported Cadent funding Centres for Warmth.



We also asked "To what extent did they support Cadent educating customers on the dangers of Carbon Monoxide?" and 87% of stakeholders agreed with Cadent funding this.

The report supported Cadent's holistic approach to tackling fuel poverty, whereby a household is supported with a combination of services/advice.

Centres for Warmth

The teams running the centres also fed into the development of this initiative, when considering the successes of the existing centre projects and opportunities for enhancements, based on the specific needs of the customers / households already being supported.

The Energy Diaries research

Through extensive research with customers living in fuel poverty over a period of several months, we then engaged with experts such as Citizen's Advice, NEA and a suite of other charities operating in this space to co-create a number of additional initiatives that Cadent could offer to its customers. This was one of these initiatives.

Charity Partnerships

We have strategic level partnerships in place with around 40 consumer advice organisations and charities. We engage regularly to assess the benefits of existing projects and consider options elsewhere, taking the opportunity to benchmark against others and seek to learn.

Updated June 2024

Department for Energy Security and Net Zero found that 13% of households were fuel-poor in 2023, that's 3.17 million households. The average fuel poverty gap of £417 up from £348 in 2022 in real terms.⁵.

Households in fuel poverty depend on the interaction of key drivers including energy efficiency measures and income max. Energy efficiency measures lifted 112,000 households out of fuel poverty between 2022 and 2023. Low-income households grew faster than the median income in 2023 due to income maximisation, reducing fuel poverty. This was partially offset by rising housing costs. In 2023 energy prices rose moving 28,000 households into fuel poverty.6.

There are social consequences of such poverty, including family issues, impacts on social and cultural lives, and higher rates of crime and victimisation."

Outcomes, Associated Actions and Success Criteria

The partnership with Halton Brook/Palace fields Community Centre will form part of Cadent's wider Centres for Warmth network. The Centre for Warmth project model relies on the provision of VCMA funding, materials and resource to a community centre located in an area of high deprivation, fuel poverty, and carbon monoxide risk. The increased levels of funding, resource and materials enable the community centre to ramp up its existing support for customers in vulnerable situations.

Project Outcomes

The Halton Brook/Palace fields Community Centre - Centre for Warmth Project aims to achieve the following outcomes:

- Individuals will report increased levels of household income.
- Individuals will report an increased awareness on the dangers of carbon monoxide (CO) and have a reduced risk of harm caused by CO.
- Provide support to lonely local residents, ensuring that they can access the community centre and the services it offers.
- Provide individuals with energy efficiency advice and carbon monoxide awareness.
- Individuals will report reduced levels of anxiety in fearing a utility outage.

Associated Actions

The Halton Brook/Palace fields Community Centre will implement the following associated actions to deliver the project's outcomes:

- Individuals will report increased levels of household income through working with the centre's specialist benefits advisors. The specialist benefits advisors will support households to identify and access previously unclaimed benefits.
- Individuals will report reduced levels of anxiety in fearing a utility outage through be assisted to register to the Priority Services Register (PSR). Centre staff will all receive an awareness on the PSR and will help eligible households through the registration process.
- Clients will report an increased awareness on the dangers of carbon monoxide (CO) and have a reduced risk of harm caused by CO. This will be achieved through the centre's staff providing CO awareness conversations and distributing CO alarms to the most at-risk households.

Success Criteria

The success of the project will be measured against meeting the below criteria:

- 8872 customers will attend the centre for various services across the 2-year project.
- Around 3,976 customers will receive specialist advice on identifying and accessing previously unclaimed benefits/income maximisation.
- Around 1,508 customers will receive help and support on energy efficiency.
- Around 1,000 customers will receive an awareness conversation on the dangers of CO. Approximately 200 of the most at-risk customers will also receive a CO alarm.
- Around 1,760 customers will improve their awareness of the PSR. Approximately 600 eligible customers will also be supported to register.

- To deliver income maximisation to an extra 500 people.= 4,476
- To deliver energy efficiency advice to an extra 760 people = 2268
- To deliver CO advice to an extra 760 people = 1,760
- To deliver PSR advice to an extra 760 people.
- To register an extra 76 people to the PSR.=676
- 360 people will receive a free hot meal.

Updated June 2024

The services listed below will be provided via two Centres for Warmth, Halton Brook and Palace Fields. Community influencers will deliver services and activities to address all the vulnerabilities experienced by people within the community covering the full demographic.

Associated Actions

The additional funding will enable the centre to extend the three community influencers contracts for an additional 21 months to ensure the centre can continue delivering the 'Centre for Warmth' project.

The additional funding will also enable the co-ordination and delivery of "Warmer Night" sessions through the winter months and "Summer Kettle" sessions through the summer months to ensure all children that receive a free hot school dinner will still receive a hot meal through the summer holidays.

The Warmer Night & Summer Kettle sessions are where the centres will extend their opening hours to help families who are struggling to pay for energy and food.

This will allow people to attend the centres one-two days per week for three hours, receive a hot healthy meal and advice on a range of topics. This is also an opportunity to tackle loneliness and isolation, by building strong relationships within the community to help them address any issues in a safe space.

Success Criteria

The success of the extension will be measured against achieving the additional objectives:

- Deliver PSR advice to 1,900 individuals.
- Distribute 3,000 PSR leaflets at community events.
- Register 300 individuals onto the PSR.
- Provide energy efficiency advice to 1,000 individuals via in-depth one-to-one or group conversations.
- Distribute 9,600 energy efficiency leaflets at community events.
- Provide 14,400 individuals with income maximisation services.
- Provide 40 slow cookers at dedicated events and as individual needs emerge.
- Provide 121 carbon monoxide awareness conversations to 1,100 individuals.
- Distribute 3,000 carbon monoxide leaflets at community events.
- Distribute 1,300 carbon monoxide alarms to people living in a vulnerable situation and do not already have one.
- Refer 40 individuals for a free gas safety check.
- 14,400 individuals will attend the centre and have a conversation with others, alleviating loneliness, and isolation.

Supporting households to maximise their income

Cadent worked with SIA Partners to evaluate the average 5-year gross present value of supporting households to maximise their income. SIA Partner's based their analysis on the "actual" data from a 3-month project between Cadent and NEA, and historic data from NEA over the past 3 years.

SIA Partners calculated an average 5-year gross present value of supporting households to maximise their income of £1,717.11.

Educating customers on the dangers of carbon monoxide

Cadent also employed SIA Partners to evaluate the forecasted social return on investment of several RIIO-GD2 business plan elements. These elements included CO education, CO alarm distribution and the repair/replacement of gas appliances.

SIA Partners pointed to a number of factors that influenced the social value generated by educating customers on the dangers of carbon monoxide:

- A reduction in A&E visits linked to CO;
- A reduction in long term hospitalisations linked to CO;
- · A reduction in deaths caused by CO;
- A reduction in time of work due to injury caused by CO;
- A reduction in ambulance call outs linked to CO;

SIA Partners calculated the average 5-year gross present value of a CO educational conversation to be £8.73 - this is based on a 1-2-1 conversation with an 80% retention rate.

Supporting households to register to the Priority Services Register

Cadent worked with SIA Partners to evaluate the average 5-year gross present value of supporting households to register to the PSR. SIA Partner's based their analysis on the DNO proxy bank value for an avoided stress management course.

SIA Partners evaluated an average 5-year gross present value of £143.89 for a single PSR registration.

The Cost of loneliness

The Centre for Warmth project will reach customers living in urban areas of Cadent's network.

- [1] BBC report found that 46% of England's urban population is aged 65 or over.
- [2] One-fourth of the population aged 65 years and older reported feelings of loneliness.



[3] Social Psychiatry and Psychiatric Epidemiology reported a net present value of £6,000 for people who reported being lonely most of the time. This figure was across a 10-year period and equates to £600 per annum. This research concluded that older people who feel lonely are at greater risk of developing conditions such as dementia and depression. [4] The health foundation reported that 21% of older people who live alone, or face feelings of loneliness visit their GP at least once a month. This places pressure on front-line services since many people who experience loneliness think of their GP as someone they can relate to and who will listen to them, engaging in an open, friendly dialogue. This equates to an overall benefit of £1,656,000 across the entire customer group supported through the project.

This project aims to reach 8,872 people through the 2-year project, equating to a saving of £1,200.00 per customer.
