





Kimberley Roadworks – Relief and Recovery Grant Scheme For the attention of Kimberley Based Businesses

As you will be aware there will be significant roadworks taking place in Kimberley town centre from Monday 29^{th} July -6^{th} October. It's expected there will be a negative on many businesses in the town centre during this period.

Cadent are running a compensation scheme for businesses impacted by the works but this is not expected to pay compensation for some time.

Kimberley Town Council and Broxtowe Borough Council would like to offer affected businesses the opportunity to apply for grant funding of up to £1000 to help with lost income or short-term cash flow challenges. **No match funding** is required. The principal requirement for a successful application will be to demonstrate the likely impact on the business during the roadworks.

To apply, please fill in the paper form given out with this flyer and hand it in to the Parish Hall Office on the Cricket Ground** between 12:00 and 14:00 Monday – Friday, by Monday 12th August at the latest. We will endeavour to assess applications as quickly as possible and pay any awarded grants without delay. Payments will be made direct by Broxtowe Borough Council.

The funding source for these grants is the Kimberley Levelling Up Fund.

There are a few conditions:

- 1. Grants of up to £1,000 may be awarded;
- 2. Businesses must remain open/trading during the works;
- 3. Businesses **must** apply to the Cadent compensation scheme (above) when they are able to;
- 4. If a business is successful in receiving compensation from the Cadent scheme, any grant given under this scheme will be repaid within 18 months, in up to three instalments. Businesses unsuccessful in any Cadent application will not have to repay this grant.
- 5. Any other assistance from the public sector (e.g. a reduction in Business Rates, should these be chargeable) will be assessed on a case-by-case basis.
- Businesses based in the home, as opposed to a shop, must prove how their business will be impacted by the Cadent works. This will also be assessed on a case-by-case basis.
