#### THE GAS ACT 1986

#### THE ACQUISITION OF LAND ACT 1981

Cadent Gas Limited (company registration number 10080864 and in this order called the "acquiring authority") makes the following order -

- 1. Subject to the provisions of this order, the acquiring authority is under section 9 of and paragraph 1(2) of Schedule 3 to the Gas Act 1986 (the "1986 Act") hereby authorised to purchase compulsorily the new rights in, on, under or over land described in paragraph 2 (the "Order Land") for the purpose of carrying on the activities authorised by its gas transporter licence under the 1986 Act, including maintaining an efficient and economical pipeline system for the conveyance of gas, and in particular for the construction, use, operation and maintenance of a diversion of the Whassett to Barrow high pressure gas pipeline comprising underground pipelines, compound and associated development to facilitate the transfer of gas between Whassett and Barrow in Cumbria.
- 2. The new rights to be purchased compulsorily in, on, under or over land under this order are identified in Table 1 of Schedule 1 in accordance with the definitions set out at paragraph 6 below. The land over which the new rights are to be compulsorily purchased is shown delineated black and coloured light blue and yellow on the said maps prepared in duplicate, executed on behalf of the acquiring authority and marked "Map referred to in The Cadent Gas Limited (Whassett to Barrow High Pressure Gas Pipeline Diversion) Compulsory Purchase Order 2023".
- 3. Parts 2 and 3 of Schedule 2 to the Acquisition of Land Act 1981 are hereby incorporated with this order subject to the modifications that references in Parts 2 and 3 of Schedule 2 to the Acquisition of Land Act 1981 to "the undertaking" shall be construed as including the works to be constructed and used by the acquiring authority in, on, over and under the land subject to this order.
- 4. Where pursuant to this order a new right is acquired by the acquiring authority, it shall be exercisable at all times by the acquiring authority, its successors in title, lessees, licensees, assigns and those deriving title from them, and all persons authorised by any of these.
- 5. In the Schedules to this order, where a party's interest has already been identified and described in a plot then if they are identified in a later plot their address has not been repeated.
- 6. In Table 1 of Schedule 1 to this order, the following terms shall have the following meaning:
