Cadent's changes to standard domestic connection charges come into effect from 01 May 2021


What's changing:

Cadent's charges for standard domestic connections are being revised with effect from 01 May 2021

Cadent has revised its charges to reflect the current costs it expects to incur in providing connections services consistent with our approved charging methodology.

Current customer charges – new & existing connections

The charges included in the table below reflect a standard domestic gas connection, which includes Cadent carrying out all trench excavation and reinstatement required for the job.

These charges include an allowance (known as the Domestic Load Connection Allowance or DLCA) as specified under Cadent's Standard Licence Condition 4B, Connections Charging methodology, for the connection to our main and the first 10m of pipe laid in land dedicated for public use (typically the highway).

These charges exclude any charges that may be made by individual Highways Authorities under the Traffic Management Act 2004. Where applicable, these will be added to the charges above.

Application Criteria

The standard charges are applicable for up to 63 metres of service pipe to be laid on land owned or occupied by the person requiring the connection, where the service termination is not above the exterior ground surface level. To be eligible for a standard charge, all the following criteria must be met:

- the new connection must be for individual premises situated within 23 metres of one of our relevant mains, operating at a pressure equal to or less than 2 barg, with no engineering difficulties or other obstacles present that would result in more than 23 metres of pipe being laid to the premises boundary;
- the premises is being used or proposed to be used mainly or wholly for domestic purposes;
- no more than 10 gas connections
- there is no existing gas supply to the premises;
- the premises is not situated within a "live" Infill Scheme (see Other Information below)

Any individual premises meeting the above criteria is eligible, regardless of whether the enquiry is part of a single or multiple connection request. Where the above criteria are not met, a bespoke quotation will be provided for the required new connection works.
