Al	Artificial Intelligence – computer systems able to perform tasks normally requiring human intelligence, such as visual perception, speech recognition, decision-making, and translation between languages.
AICR	Adjusted Interest Coverage Ratio
APPG	All-Party Parliamentary Group
AWS	Affordable Warmth Solutions – a Community Interest Company that assists qualifying homes in the most deprived areas in England, in partnership with Cadent.

BAME	Black, Asian and Minority Ethnic communities
Bar	Unit of measurement of pressure. 1 bar = 14.5 psi. This is roughly equal to average atmospheric air pressure at sea level. Most car tyres are inflated to around 2 bar or 30 psi. Bar _g and Bar _a may occasionally refer to 'gauge' and 'absolute' pressures respectively. Unless stated, Bar is a gauge pressure.

CEG	Customer Engagement Group – an independent group set up by Cadent to challenge us on the ambition of our plans and bring experience from different sectors into our thinking.
CEO	Chief Executive Officer of Cadent Gas Limited – the highest-ranking executive in a company, responsible for making major corporate decisions, managing the overall operations and resources of a company, and acting as the main point of communication between the board of directors and corporate operations.
Chairman	The Chairman of the Board of Directors of Cadent Gas Limited
СНР	Combined Heat and Power – the use of a single unified system to supply both the heat and power requirements of a project, minimising the waste of heat. The power is produced through gas turbines or another generating source. The exhaust heat is harnessed for requirements and beneficial uses other than electricity generation.

CIA	Chemical Industries Association – an organisation representing and advising chemical and pharmaceutical companies located across the UK.
CISBOT	A robot for repair of cast iron pipes that seals the joints in natural gas pipelines from the inside.
CIVS	Customers in Vulnerable Situations – customers who have specific needs that are dependent on their energy supply. This may include customers who have certain medical requirements, communication needs, mobility difficulties, are of pensionable age or have young children.

CNG	Compressed Natural Gas – natural gas that is compressed into gas cylinders, mainly used as an alternative for liquid fuels in road vehicles. CNG remains in a gaseous state irrespective of the amount of pressure.
CNI	Critical National Infrastructure – elements of infrastructure the loss or compromise of which could result in: a) Major detrimental impact on essential services; and/or b) Significant impact on national security, national defence, or the functioning of the state.
со	Carbon Monoxide – a colourless, odourless, tasteless gas that is toxic to people and animals in concentrations above about 35 ppm.
CO ₂	Carbon Dioxide – a colourless, odourless gas produced by burning carbon and organic compounds and by respiration.
CO₂e	Carbon Dioxide equivalent – a standard measure of carbon footprint that describes different greenhouse gases in a common unit.

ECV	Emergency Control Valve – a valve at the extremity of the gas distribution network, providing the facility to isolate gas from flowing into the customer property downstream.
EIC	Energy Innovation Centre – an organisation working in partnership with ten gas, electricity and water utilities and the Energy Systems Catapult (ESC), aiming to bridge the gap between industry and innovators.



ENA	Energy Network Association – an industry body funded by UK gas and electricity transmission and distribution licence holders. This provides a strategic focus for the energy networks sector by communicating key messages and recommendations, supported by technical expertise. The ENA also records faults, defects and safety information on behalf of the industry.
EoE	East of England – one of our regional GDNs – the network that consists of East Midlands (EM) and East Anglia (EA).
ER&R	Emergency Response and Repair – the part of our operations which delivers the gas emergency service from when a call is received from a member of the public to when a permanent repair of the network is completed.
EUA	Energy and Utilities Alliance – a not-for-profit trade association that provides an industry voice to help shape future policy direction within the energy sector.
EV	Electric Vehicle
Exit capacity	This concerns rights to take gas from the National Transmission System (NTS) up to a certain flow rate. We receive an allowance to cover the cost of doing this. It is classed as a 'pass through' cost, which means that the costs are outside of the network's control and can be passed on to the customer. The mechanism provides incentives to gas distribution networks to minimise the impact on the NTS and to reduce the amount of capacity that is planned. If we spend less than the targeted cost, we are rewarded with a proportion of the saving.
EZ valve	Valves and line stops that enable rapid insertion into gas pipelines.

FFO	Funds From Operations
Field force	Employees in operational roles who work on the gas pipeline network 'in the field', carrying out maintenance, repairs or emergency response.
First Call Operative	Our emergency field force engineers
FPNES	Fuel Poor Network Extension Scheme – an Ofgem scheme helping off-grid households with funding towards the cost of connecting to the gas network.
FTE	Full-Time Equivalent – this refers to the number of roles performed either by single full-time employees or combinations of part-time employees.
Fuel poverty	Fuel poverty in England is measured using the Low Income High Costs (LIHC) indicator. Under the LIHC indicator, a household is considered to be fuel poor if: a) they have required fuel costs that are above average (the national median level); and b) were they to spend that amount, they would be left with a residual income below the official poverty line. (As defined at https://www.gov.uk/government/collections/fuel-poverty-statistics)

Gas holder	A large container for the storage of gas.



Gas Safe Register	The official registration scheme in the UK, Isle of Man and Guernsey for installers and maintenance engineers dealing with gas appliances.
Gas Transporter	A company that owns part of the gas Local Transmission System (LTS) and holds a gas transporter licence under the Gas Act 1986.
GD1	The first gas distribution price control under the RIIO framework that was set by Ofgem for the period from 1 April 2013 to 31 March 2021.
GD2	The second gas distribution price control under the RIIO framework that will be set by Ofgem for the period from 1 April 2021 to 31 March 2026.
GDN	Gas Distribution Network – a regional gas distribution network. Together with the National Transmission System (NTS), the regional GDNs combine to form the national gas distribution system in Great Britain.
GDPCR1	The gas distribution price control that was set by Ofgem for the period from 1 April 2008 to 31 March 2013.
GDSP	Gas Distribution Strategic Partner – GDSPs undertake much of our replacement and connections work. Cadent's GDSPs are currently: • Morrison Utility Services Limited and Skanska Construction UK Limited (a joint-venture known as tRIIO) in relation to our East of England (EoE) and North London (NL) GDNs • Balfour Beatty Utility Solutions Limited in relation to our West Midlands (WM) and North West (NW) GDNs
GLA	Greater London Authority – the devolved regional governance body of London, with jurisdiction over both counties of Greater London and the City of London.

Greenhouse Gas or GHG	A gas that contributes to the Greenhouse Effect by absorbing infrared radiation and trapping heat from the sun in the Earth's atmosphere. Carbo dioxide and chlorofluorocarbons are examples of greenhouse gases.
GS(M)R	 Gas Safety (Management) Regulations 1996 – these regulations apply to the conveyance of natural gas (methane) through pipes to domestic and other consumers and cover: Safety, particularly for domestic consumers, including minimising the risk of a gas supply emergency Arrangements for dealing with supply emergencies Arrangements for dealing with reported gas escapes and gas incidents Gas composition
GSOP	Guaranteed Standards of Performance – standards that we must meet for our customers, such as completing work on time or dealing with complaint within timeframes set by Ofgem.
GWh	Gigawatt hour – a measurement of energy transmitted or used over a period of time. One GWh = one billion Watt hours.

Hy4Heat	A gas industry innovation project to establish if it is technically possible, safe and convenient to replace natural gas with hydrogen in residential and commercial buildings and gas appliances.
HyDeploy	A gas industry innovation project in conjunction with Keele University to trial injection of a blend of natural gas and hydrogen into the network.
HyDeploy2	The second phase of HyDeploy, which will follow the same approach used at Keele, but this demonstration will use hydrogen to provide energy to a wider variety of customers – more representative of the UK as a whole – on a public gas network.
HyNet North West	A conceptual study to introduce hydrogen into the gas network in an industrial part of Manchester and Liverpool.

IBoxx trombone index	IBoxx indices provide benchmarks that track global markets. Ofgem is proposing an 11 to 15 year "trombone" IBoxx average index to determine the cost of debt for GDNs in RIIO-2. The averaging period would start on 1 November 2009 and end on 31 October 2020 for 2021-22 (11 years), and will advance by a year each year, trombone-like, until the end of the RIIO-2 period the averaging period length reaches 15 years. For 2025-26, the averaging period will start on 1 November 2009 and end on 31 October 2024 (15 years).

ICS	Industrial Control Systems – automated systems used to control the operation of our gas network.
IGEM	Institution of Gas Engineers & Managers
IGT	Independent Gas Transporter – IGTs design, construct, develop, operate and maintain their own local networks, which are additional to the main GDNs. They cover a relatively small proportion of the gas market, supplying around 1 million homes plus some industrial and commercial premises. Some are in rural areas and others are in new developments. There are currently six IGTs in the UK: GTC Pipelines, Independent Pipelines, ES Pipelines, Energetics, Fulcrum Pipelines and SSE Utility Solutions Ltd (on behalf of Indigo Pipelines Ltd). The point where an IGT's network connects to the National Grid network is called a Connected System Exit Point (CSEP).

LTS	Local Transmission System – the major distribution pipelines that transport gas downstream of the National Transmission System (NTS) (which is not owned or operated by Cadent) at the higher pressure tiers: HP or IP.

mbar	Millibar – unit of measurement of pressure. 1,000 millibars = 1 bar
MEG	Monoethylene Glycol – a chemical substance that is used in the oil and gas industry to prevent the formation of hydrates and resulting blockages in pipelines and equipment.

Natural Gas	A flammable gas, consisting largely of methane and other hydrocarbons, occurring naturally underground. It often includes varying amounts of other higher alkanes, and sometimes a small percentage of carbon dioxide, nitrogen, hydrogen sulphide, or helium.
NEA	National Energy Action – a charity that we collaborate with on fuel poverty issues.
Needs Codes	A common set of industry codes used to identify customers' individual needs as part of the Priority Services Register (PSR).

NGN	Northern Gas Networks – a Gas Distribution Network Operator owning and operating a regional GDN in the north east of England.
NIA	Network Innovation Award – a set allowance each gas network company receives as part of their price control allowance.
NIC	Network Innovation Competition – an annual opportunity for gas network companies to compete for funding for the development and demonstration of new technologies, operating and commercial arrangements.
NIC	National Infrastructure Commission – an executive agency responsible for providing expert advice to the UK Government on infrastructure challenges facing the UK.
NISR	Network and Information Systems Regulations (2018) – legal measures aimed at boosting the overall level of security (both cyber and physical resilience) of network and information systems for the provision of essential services and digital services.
NL	North London – a Cadent regional GDN, also referred to as London (LON)
NOMs	Network Output Measures – deliverables relating to the condition, performance and risk of a gas distribution network that GDNs are required to deliver during GD1.
NPV	Net Present Value – a calculation businesses use in investment planning to analyse the profitability of a future investment or project.
NTS	National Transmission System – the national high-pressure system consisting of 4,000 miles of pipelines, terminals, compressor stations and offtakes. Regional GDNs and directly connected customers take gas from the NTS.

OBR	Office for Budget Responsibility – a non-departmental public body established by the UK government to provide independent economic forecasts and independent analysis of the public finances.
ODAs	Other Direct Activities – work carried out on our networks that does not fall into the categories of emergency, repair or maintenance work.
ODI	Output Delivery Incentive. May be financial or reputational in nature, denoted by (F) (R) respectively. Financial ODIs may be punitive only (-), opportunity only (+) or have both possibilities (+/-).
Offtake	The point in a pipeline system where gas is taken into another system – from the NTS into a network, or between two networks – or from a network via a supply pipe to a consumer.
Ofgem	Office of Gas and Electricity Markets – the UK government-appointed regulator for the electricity and natural gas markets.
opex	Operational Expenditure – money spent on the ongoing costs of running an organisation, business, product, service or system, such as administration, research & development, utility services, rent on premises, maintenance, office supplies and wages.
OptiNet	A gas industry innovation project to investigate how smart pressure control, compression and storage might be used in parallel to alleviate constraints in the operation of gas networks.
ОТ	Operational Technology – technology embedded in the physical assets in our networks enabling us to run the networks safely and efficiently.



Outputs	The performance measures set within the RIIO price control framework which are a key driver of the level of expenditure (and hence revenue) that Gas Distribution Network Operators require during the price control period.

PPE	Personal Protective Equipment – safety equipment that forms the 'last line of defence' worn by our engineers on site, which may include boots, overalls, high-vis jacket, ear defenders, hard hat and gloves.
PPF	Pension Protection Fund – a statutory fund in the UK, intended to protect members if their Defined Benefit (DB) pension fund becomes insolvent. It was created under the Pensions Act 2004.
PR19	2019 Price Review – the recent Ofwat price review for the water industry.
PRS	Pressure Reduction Station – equipment that facilitates the reduction of pressure between different levels or 'tiers' in the distribution network. The term may apply to offtakes and governors but is generally used for equipment that reduces the pressure between High Pressure (HP) and Intermediate Pressure (IP) tiers in the GDN, or between Intermediate Pressure (IP) and Medium Pressure (MP) tiers.
PSR	Pipelines Safety Regulations 1996 – regulations for health and safety in offshore gas installations and the onshore domestic gas market. They cover responsibilities, arrangements to prevent accidents and damage, emergency plans and notification of incidents.
PSR	Priority Services Register – a registration process to ensure that customers can be prioritised in the event of an emergency if they have specific needs that are dependent on their energy supply. Extra help can then be provided to customers who have certain medical requirements, communication needs, mobility difficulties, are of pensionable age or have young children.

The first gas distribution price control under the RIIO framework, set by Ofgem for the eight gas distribution networks, for the period from 1 April 2013 to 31 March 2021.
The second gas distribution price control under the RIIO framework that will be set by Ofgem for the period from 1 April 2021 to 31 March 2026.
The third gas distribution price control under the RIIO framework that will be set by Ofgem for the period from 1 April 2026 to 31 March 2031.
Return on Regulatory Equity – financial return achieved by shareholders according to a price control regime. This is used for comparison with the cost of equity originally allowed.

r-squared	A statistical measure of how closely data are fitted by a regression line. An r-squared value of 1 represents an exact fit between the modelled line and source data, with lower numbers indicating a less close fit.
